Directions to the Barn from Byron:

Take Highway 14 to Byron
Turn north at Kwik Trip
(this is county road 5)
Take county road 5 north 9 miles
...the farm is on the right hand side of the road
(the east side) - you
will see a large white pole barn
a large red barn, several white out-buildings
and a dark brown square house.
The number on the mailbox is 10038.
The sign on the pole-barn says "RideAbility".

Directions to the Barn from Rochester:

Go North on Highway 52 through Rochester
Take the 75th street Exit and go west
Go approximately 8 miles on 75th street
(through Douglas and Genoa to county road 5)
Turn right (north) on county road 5
The farm is 2.3 miles north on county road 5,
on the right hand (east) side of the road
you will see a large white polebarn
The number on the mailbox is 10038.
The sign on the pole barn says "RideAbility".

Directions to the Barn from Pine Island:

Go South on main street through Pine Island
after main street makes a right turn, then
Turn left and go south on County Road 3
(go about ½ mile)
Turn right on County Road 5 south toward Byron
The farm is 3 ½ miles on county road 5,
on the left hand (east) side of the road
you will see a large white polebarn,
a large red barn, several white outbuildings
The number on the mailbox is 10038.
The sign on the pole barn says "RideAbility".

Follow your GPS to the RideAbility Barn: **Note:** *Do not use the address of 10038 County Road 5 NW.*

*Use the Google site name of RideAbility (we are registered Google site).
